Dubbo Touch Association- Representative Financial Support

Purpose of Policy

Provide a structure for Dubbo Touch Association (DTA) to offer a fair system for financial support to all representative individuals of the club (including players, referees, coaches and officials) and encourage broad participation in activities relating to the running of the Association.

Description

DTA would like to offer a reasonable and fair procedure for financial assistance. All representative individuals are eligible for a maximum one off payment of \$200 per year which is equivalent to 200 credit points. The payment is provided on a retrospective basis ONLY, where the player may accumulate a maximum of 200 credit points prior to receiving the \$200 payment (or part thereof). Payment will be made to the individual by DTA and is only to support players and officials undertake representative duties. Payment directly to the individual will only be made on presentation of a paid invoice after the event. Credit points may also be used to purchase compulsory DTA playing uniform items or to pay for accommodation booked and prepaid by DTA. Below are various methods in which credit points can be accumulated.

Role	Credit points towards payment
Committee Position	100
Assistant Committee Position	50
Coach	50
Manager	50
Coach Junior Competition team	10

Guidelines

- In order to match the representative season of each year the credit points system will operate over the calendar year – 1 January to 31 December.
- The payment is available for players, referees, coaches and officials that have been selected to represent DTA at Country Championships, Hunter Western Hornets, NSW State Cup, National Touch League, Australian representation or other tournament that has been endorsed by the DTA Committee. For anything different, a letter must be submitted to a DTA Committee Meeting for consideration.
- Eligible individuals can be associated with either senior or junior Touch.

- Credit points can be transferred to immediate family members (parent, spouse, sibling, offspring) to use.
- Credit points must be used in the calendar year they are accumulated and cannot be carried over into consecutive calendar years.*
- Your contribution to DTA can be rewarded ONCE ONLY.
- A player must indicate their intention to apply for financial support prior to competing at a tournament. The representative individual must write to DTA (email or hard copy) asking for financial assistance and indicate how they have accumulated sufficient credit points.
- DTA reserves the right not to support representative individuals who have acted contrary to the Dubbo Member Protection Policy or have been cited by the judiciary or have been sent off in the DTA competition or other representative tournaments.
- The Representative Players Coordinator is to maintain an up to date record of any player or official using their credit points. Changes to this record are to be tabled at each DTA committee meeting.
- The Representative Players Coordinator will also ensure payments are made on behalf of the individual in a timely fashion.

**Credit points attained through DTA Junior Competition (August-December) may be carried over to the next calendar year. Credit points carried over must be used by the end of the following Junior competition. A written request must be submitted to the Representative Player Coordinator to access credit points attained in the DTA Junior Competition.*
